

**TRUSTEE RESOLUTION CALLING FOR AN ELECTION**

BE IT RESOLVED, the Board of Trustees for Fromberg School District No. 6, Carbon County, State of Montana, will hold the Annual Regular School Election on Tuesday, the 6<sup>th</sup> day of May, 2025, which date is not less than seventy (70) days after the passage of this resolution.

The purpose of the election is to elect one (1) trustees for an unexpired one-year term and one (1) trustee for a full three-year term. Approval of additional levies to operate and maintain the Fromberg Schools for the 2025-2026 school year such as a General Fund Levy may also be requested. If it is later determined that any portion of the election is not required, the Board of Trustees authorizes Crystal Roascio, County Election Administrator, to cancel that portion of the election in accordance with 13-19-202 and 20-20-201, MCA.

Three electors of this district who are qualified to vote at such election are hereby appointed to act as judges at the election at each voting place as follows:

**TRUSTEE RESOLUTION CALLING FOR AN ELECTION BY MAIL BALLOT**

BE IT RESOLVED, the Board of Trustees for the Fromberg School District No. 6, of Carbon County, State of Montana, will hold the Annual Regular School Election by mail ballot on Tuesday, the 6<sup>th</sup> day of May, 2025, which date is not less than seventy (70) days after the passage of this resolution.

The designated place of deposit will be located at Fromberg Elementary School Office, 319 School Street, Fromberg until 4pm on election day, or, Carbon County Election Office, 17 West 11<sup>th</sup>, Red Lodge until 8pm on election day.

The purpose of the election is to:

- Elect one (1) trustee for an unexpired one-year term and one (1) trustees for a full three-year term.
- Approval of additional levies to operate and maintain the General fund for FY 26 may also be requested.

If it is later determined that any portion of the election is not required the Board of Trustees authorizes Crystal Roascio, County Election Administrator, to cancel that portion of the election in accordance with 13-1-304 and 20-3-313, MCA.
