August 8, 2024

Commissioners Scott Miller, Scott Blain, and Bill Bullock, and Administrative Officer Angela Newell were present.

8:30 Pledge of Allegiance.

9:00 Sanitarian Barbara Krizek, Sanitarian Jesse Guiterrez, and Assistant Lori Kane met for the Environmental Health Quarterly update. Krizek reviewed the written report (attached). Krizek noted Carbon County's septic permitting volume has held steady where there seems to be a decrease in surrounding counties. Guiterrez discussed Short-Term Rental inspections, the contemplated cap on Short-Term Rentals in the City of Red Lodge, and consistent issues with requests to license older properties as Short Term Rentals and them being advertised for a higher capacity than the septic system is built for.

10:00 County Attorney Alex Nixon met for his regular meeting. Nixon has not received a revised settlement offer in Bennett. Commissioners discussed the School Resource Officer Agreement (Nixon has reviewed and approved the language), Airport interlocal (Westwood working on a revision), Complaints at the D7 Subdivision regarding the concrete plant, and code enforcement procedures.

#### **ENVIRONMENTAL/ON-SITE WASTEWATER**

- 29% greater volume of Septic Applications (2023 YTD = 59 applications; 2024 YTD = 76 applications).
  - o Data indicates Carbon in a "bubble" as Installers/Engineers reporting decrease in other counties
- Mutual aid (backup) agreement with Big Horn County (Spry): awaiting executed return

#### **EMERGENCY PREPAREDNESS/RESPONSE**

- June 2022 Flood: East Rosebud Lake Association site visit and on-going issues
- Bridger Train De-Railment: Clean-up and well monitoring in progress until remediated.

# LICENSED ESTABLISHMENTS (DPHHS)

- Goal: 15 non-Short Term Rental (STRs) inspections per month for end of October completion (ie "90%"+).
