11:00 School District Boundaries - 2024 Tax Bill. Cheryl Brown, Susan Berard, David Berard, Rich Lynde, Jessica Black-Swan, Mike Bornus, Todd Atkinson, Kristie Atkinson, Lori Lynde, Treasurer/Superintendent of Schools, Lori Kane, Assistant Superintendent of Schools, Leah Niemi Deputy Treasurer, Tom Kohley, GIS Coordinator and Chad Beckman, Area Manager, Montana Department of Revenue attended the meeting in an effort to clarify School District Boundaries between Red Lodge and Belfry Schools. Kohley, Beckman, and Lori Lynde reviewed the history of school boundary transactions and errors that were introduced into the map when it was digitized. Berard discussed the reliance on the state map for determining home districts and issues with the costs of providing services to out of district students. Lori Lynde, Treasurer/Superintendent of Schools provided an overview of the statutory process to be followed, outlined under 20-6-105 Montana Code Annotated. The process must start with a petition presented to both the affected School Districts. Kohley advised that school district boundaries were used to create other special districts including Fire Districts, EMS Districts, Cemetery Districts, School Districts and noted the County's need to track the historic School boundary changes to determine affects on other special districts. Presiding Officer Scott Miller recessed the meeting until the next agenda item.
