January 23, 2025

Commissioners Scott Blain, and Bill Bullock, Deputy Clerk Katrina Kruger and Administrative Officer Angela Newell were present. Commissioner Miller was out sick.

- 8:30 Pledge of Allegiance.
- 8:35 Public Comment. Seeing none, Presiding Officer Scott Blain recessed the meeting until the next agenda item.
 - 9:00 Employee Time Status Review
 - 9:30 City of Red Lodge. Mayor Westwood was unavailable for the meeting.

10:00 County Attorney Alex Nixon joined the meeting. Blain reported he had sent Nixon a spreadsheet identifying stolen road signs, costs and the locations where the stolen signs had been found. Blain seconded. Motion carried.

11:00 Hiring Authorization -Deputy Treasurer. Niemi joined the meeting to request an Internal Hiring Authorization for Deputy Treasurer / Superintendent of Schools Administrator due to the vacancy left by the retirement of Lori Lynde and the appointment of Leah Niemi as the Treasurer. Newell noted the duties of Superintendent of Schools Administrator is being absorbed into the Treasurer's Office. Bullock moved to approve the Hiring Authorization for Deputy Treasurer and Deputy Superintendent of Schools; Blain seconded. Motion carried.

Devries 2 Gravel Pit Expiration. Contract Civil Attorney Jacque Papez joined the meeting. Papez noted a DEQ violation letter had been received by the County regarding the Expiration of the Devries 2 Gravel Pit. The options are to reclaim the land or to renew the permit.
